Giveaway is offered at Vitalant donor centers and mobile blood drives located in the states of New Jersey and New York

April 23, 2024 – May 17, 2024

#### Official Rules:

The giveaway is sponsored by Vitalant, a 501(c) tax-exempt charitable organization.

#### Eligibility:

The giveaway is open to United States residents who reside in New Jersey or New York, who are at least 18 years of age on the date of the selection of the grand prize winner, who created their online donor account on the website, [donors.vitalant.org](https://donors.vitalant.org), during the promotional timeframe.

Employees of Vitalant or their subsidiaries and their immediate family members, are not eligible to enter. The term "immediate family" includes spouses, siblings, parents, children, grandparents, grandchildren and other persons residing in the same household (related or not). The giveaway is void where prohibited. Residents of jurisdictions where this promotion is not permitted, or where Vitalant would be required to register or be restricted in any other way, are not eligible to win a prize.

**How to Enter:** Persons who create an online donor account via [donors.vitalant.org](https://donors.vitalant.org) between April 23, 2024 through May 17, 2024, are eligible to enter the giveaway.

**Donor or Non-Donor Entry:** Persons who create a new online donor account via [donors.vitalant.org](https://donors.vitalant.org) will automatically be entered in the giveaway. Each person may create only one online account. Creation of the online donor account does not create any obligation to make a blood donation. It is the responsibility of the person creating their account to ensure that Vitalant has the correct contact phone number and email address in the event their name is drawn as a one of the grand prize winners. Persons who do not wish to be automatically entered into the giveaway may call 877-258-4825 (press 2 for Customer Care) and leave their name and phone number to be removed from the drawing.

**Grand Prize:** A maximum prize of one (1) of five (5) Amazon.com Gift Cards valued at approximately \$500 Dollars and No Cents (\$500.00) will be awarded to five (5) separate Grand Prize Winners.

**Selection of Grand Prize Winners:** The grand prize drawing will be held under the supervision of three Vitalant employees, whose decisions are final and binding. Winner(s) will be selected as follows: All eligible entries, during the Giveaway Period, will be combined into one list. Five (5) potential prize winners will be selected from the list in a random drawing to be held on or about May 22, 2024. The potential prize winner will be notified using the email address and phone provided with Entry on or around May 22, 2024, and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. Failure by the potential prize winner to respond within seventy-two (72) hours of notification and after the second of two (2) attempts will result in disqualification and an alternate potential prize winner(s) then will be selected in the same manner, from all remaining eligible Entries. If Vitalant is unable to determine and verify a potential winner after repeated alternate drawings, Vitalant reserves the right to not award all prize(s) or all elements of the Prize.

Noncompliance with any of the foregoing may result in disqualification and the selection of an alternate grand prize name. Vitalant reserves the right to permanently disqualify any person who it believes has

intentionally violated these Official Rules. The \$500 gift card will be emailed electronically to the winners' email address provided.

**Miscellaneous:** The odds of winning depend upon the number of eligible entries received according to the eligibility requirements. By entering, participants agree to be bound by these Official Rules and decisions of Vitalant.
